



Event Terms and Conditions

Malvern End to End - 8th September 2024

By applying for entry into the Event I agree with The Shakespeare Hospice that:

Registration and participation

1. The participant must comply with the booking terms and conditions, safety policy and other rules set out by the challenge provider Sky Blue Adventures available [HERE](#)
2. Participants must be 16 years or over on the date of the Event. 16 -17 year olds must be accompanied by an adult and have parental/guardian consent.
3. I will pay a registration fee of *£20.00 / £25.00 to The Shakespeare Hospice to reserve my place on the Malvern End to End event.
4. I will inform The Shakespeare Hospice Fundraising Team immediately if I am unable to take part in the Event. When my withdrawal is acknowledged, I will not be liable to raise any further sponsorship.
5. I understand that The Shakespeare Hospice have the right to refuse registration or application for a place in an Event without providing reasons for doing so and at any time.
6. Contact details provided are used to keep you up to date about the event you are taking part in. We will ask for next of kin details in case of an emergency. All details will be stored securely and are used in relation to the event you are taking part in.

Minimum fundraising target

7. I pledge to raise a minimum of £200 / £300.00 for The Shakespeare Hospice (excluding gift aid and registration fee) through my participation in the Event and understand it is the aim of this Event to raise as much above this amount as possible.
8. If at any point I feel unable to raise the pledged amount, I will inform The Shakespeare Hospice Fundraising team immediately in order that they can have the opportunity to offer assistance with fundraising.

Donations and payment terms

9. I will regularly pay all money collected on behalf of The Shakespeare Hospice to The Shakespeare Hospice directly by the following means:-

10. I understand that I agree to pledge to raise a minimum of *£200 / £300 sponsorship and will pay this amount to The Shakespeare Hospice 6 weeks before the Event, I will be liable to pay the pledged amount from my own personal funds before the event date. If more time is needed to raise and collect your sponsorship before the event, please inform the team on fundraising@theshakespearehospice.org.uk to avoid cancellation of your place.
11. I agree that if I withdraw for any reason prior to the Event, any monies raised will be non-refundable and will be treated as a donation to The Shakespeare Hospice.
12. I will only use sponsorship forms issued by The Shakespeare Hospice and not use any other type of sponsorship form (unless otherwise agreed with The Shakespeare Hospice)
13. I agree that my sponsorship forms will make it clear that the money is not given subject to any conditions and that the monies will not be returned if the Event is cancelled, or I do not complete the Event.
14. I will send The Shakespeare Hospice my completed sponsor forms with details of the names and addresses of, and amounts donated or pledged by all sponsors no later than 2 weeks after the Event. This will allow The Shakespeare Hospice to process gift aid on donations.
15. The event will take place as advertised and will only be cancelled, re-routed or stopped for reasons of safety usually caused by adverse weather conditions. Entry fees, however, are not refundable. Should the event be cancelled, all entries will be moved to an alternative date, this date will be announced as soon as possible after the initial event. There will be no additional cost for entries moved due to cancellation.

Unfortunately, if you cannot make the rescheduled date, your registration fee becomes non-refundable and be treated as a donation.

If a new date cannot be found, you will be offered a full refund minus any processing fees or you can choose to donate your registration fee.

Expenses

16. In the instance of a cancellation, The Shakespeare Hospice will not be liable to refund any expenses you may have incurred such as pre-booked travel or accommodation. Fundraising

17. I will comply with any fundraising guidance or advice issued by The Shakespeare Hospice and abide by the Code of Fundraising Practice issued by the Fundraising Regulator.
18. I will collect money only on behalf of The Shakespeare Hospice in connection with the Event.
19. I will use only lawful means to fundraise for The Shakespeare Hospice and will not do anything that harms or is likely to harm The Shakespeare Hospice reputation.
20. I will not use The Shakespeare Hospice logo without permission and will obtain all fundraising materials from The Shakespeare Hospice.
21. My fundraising **will not** include:
 - a. Raising funds by carrying out, door-to-door or unsolicited collections.
 - b. Collecting in any public place without first obtaining a The Shakespeare Hospice collectors' licence from The Shakespeare Hospice and authorisation from the local authority and any other licences or consent that The Shakespeare Hospice require me to obtain.
 - c. Collecting on private property (including shops, pubs etc) without first obtaining The Shakespeare Hospice collectors' licence from The Shakespeare Hospice and permission of the owner of the private property.
 - d. Conducting any raffle or lottery or putting on any public Event without first contacting The Shakespeare Hospice and taking any steps which, The Shakespeare Hospice require.
22. I agree that Gift Aid payments cannot count towards the pledge to raise a minimum of *£200 / £300 in sponsorship for the Shakespeare Hospice and instead will be considered as over and above the pledged fundraising total.
23. I agree that The Shakespeare Hospice can terminate my authority to fundraise on their behalf at any time by sending written notice to the address below.



Personal data and images

We will ask your permission before taking individual and group photographs of participants, but you may sometimes appear in general photographs of crowds and the event setting.
